

Limitation on Number of Obtaining Reserved Seat Tickets Using “JR-KYUSHU RAIL PASS” and Expansion of Areas Covered

1 Limitation on Number of Obtaining Reserved Seat Tickets

(1) Possible Number to Obtain Reserved Seat Tickets

\* Non-reserved seat tickets can be obtained any number of times within the validation period of the pass as before.

(2) Changing Designated Train

If a request to change the designated train is made before the departure of the train, the number of obtaining the reserved seat tickets does not count.

2 Expansion of Areas Covered

The Kagoshima main line (between Kumamoto and Uto) and Misumi line (between Uto and Misumi) will be added to the areas covered by the northern Kyushu area pass.

\* Passengers using the pass will be able to ride on the “A-TRAIN” which is one of our D&S trains (sightseeing trains).

3 Timing of Implementation

Tickets purchased or exchanged on and after April 1, 2016 (Japan time)

(1) Customers who have purchased the MCO (Miscellaneous Charges Order) overseas and then exchange it for the pass at a JR Kyushu ticketing office on and after April 1, 2016 will be subject to the new rules regardless of the issue date of the MCO.

(2) Customers who have purchased the pass directly from a JR Kyushu ticketing office on and after April 1, 2016 will be subject to the new rules.

- [1] If a 3-day pass is purchased or exchanged at a JR Kyushu ticketing office on March 28, 2016 and used starting on March 28 of the same year → The current rules are applied.
- [2] If a 5-day pass is purchased or exchanged at a JR Kyushu ticketing office on March 27, 2016 and used starting on March 30 of the same year → The current rules are applied.
- [3] If a 5-day pass is purchased or exchanged at a JR Kyushu ticketing office on March 28, 2016 and used starting on April 1 of the same year → The current rules are applied.
- [4] If a 3-day pass is purchased or exchanged at a JR Kyushu ticketing office on April 1, 2016 and used starting on April 4 of the same year → The new rules are applied.
