Independent Assurance Report

We, SOCOTEC Certification Japan (hereafter "SOCOTEC"), have performed a limited assurance engagement, in response to the entrustment from Kyushu Railway Company (hereafter "the Company"), in order to provide an opinion as to whether the subject matter information ("FY2023 GHG Emissions Calculation Report" (period: 1 April 2023 to 31 March 2024)) of the Company meets the criteria in all material respects.

Subject Matter Information and Criteria

The subject matter information for our assurance is "a report on energy-derived CO2 emissions (Scope 1, Scope 2 (Calculated value applying base emission factor and Calculated value applying adjusted emission factor))" covering the operations and activities of the Company in Japan (629 domestic sites) described in "FY2023 GHG Emissions Calculation Report" (period: 1 April 2023 to 31 March 2024).

The criteria for preparing subject matter information are "GHG Emissions Calculation Rules (Ver1.0)" and "-FY2024 edition-Act on Rationalizing Energy Use Instructions for Completing Regular Report and Medium- to Long-Term Plan (Specified

Business Operator, etc.)

In addition, the "Kyushu Railway Company Sustainability Linked Loan Framework September 2022" (hereinafter referred to as the "Kyushu Railway Company SLL Framework"), which was formulated by the Company in accordance with the Sustainability Linked Loan Principles (SLLP) 2021 established by the Loan Market Association (LMA), the Asia Pacific Loan Market Association (APLMA), and the Loan Syndication & Trading Association (LSTA) and the Sustainability Linked Loan Guidelines established by the Ministry of the Environment, for the purpose of raising funds through sustainability linked loans, stipulates that annual reporting on the progress of the SPT and verification by a third-party organization will be required.
